2003-2020 GMC/CHEVY VAN 155 Wheel Base [PN: 210160 & 210160.1]

Please read before beginning

- Stainless steel hardware may bind together • when tightening—It is recommended that you apply an anti-seize assembly lubricant to the threads of each bolt before assembly
- This installation requires two people
- Unless otherwise specified, refer to the • general torque value at the end of the instructions for specified torque values.





Assy Driver

















Figure 1. Correct orientation of mounting brackets for Chevy 155 Nerf Bars.

- 1. Assemble the nerf bar brackets into the correct orientations shown in Figure 1. The passenger side and driver side nerf bars will assemble differently, be sure to note the differences outlined in Figure 1.
 - Some nerf bar brackets will have two sets of holes; you will need to utilize the correct set of holes for each bracket to ensure the correct bracket height when mounting.
 - Use the 3/8-16 x 1 ¼" bolts, along with accompanying nuts and washers, to fasten the brackets to the nerf bar assembly.

- 2. Once your nerf bars are fully assembled, begin installation on the driver's side.
- 3. Remove the plastic step on the driver side found just inside the driver's door (take note of any wiring because you will be drilling in this area).
- 4. Hold the nerf bar up oriented correctly.
 - The front mounting bracket should be held up against the step (see figure 3) and the rear mounting bracket should be on either side of the stock van channel (see figure 4).





- 5. Front Mounting Bracket:
 - With the front mounting bracket held up against the step.
 - Drill through the bracket and the step with a ¼" drill bit (be careful of any wiring that may be on the top of the step).
 - After drilling the first hole insert a ¼-20 x 2" Button Socket Cap (70119) through the Slotted Aluminum plate hole (See figure 2.a), with a flat washer (70009) on both sides, and a ¼-20 Nylock Nut (70008).





- The head of the bolt should be on the top of the step (i.e. the bolt is going down and the nut is on the bottom of the vehicle).
- Repeat steps "ii" and "iii" until there are two bolts attaching the front mounting bracket to the bottom of the step.

- 6. Rear Mounting Bracket:
 - With the rear mounting brackets on either side of the cross-beam drill through both sides of the mounting bracket and the crossbeam with a ¼" bit.





- After drilling the first hole insert a ¼-20 x 5 ½" Hex Bolt (70088) through the hole, with a washer (70009) on either side, and ¼"-20 Nylock Nut (70008) on the end.
 - There are two extra washers for each 5" bolt for spacer if needed.
- Repeat steps "i" and "ii" so that there are two bolts holding the rear mounting bracket to the crossbeam (Try to offset these two bolts, top right and bottom left to help reduce "play" in the nerf bars).
- 7. Middle Mounting Bracket:





- Follow the same procedure outlined in step "d" to attach the middle bracket to the vehicle, using the ¼-20 x 4" Hex Bolt (70089).
 - There are two extra washers for each 4" bolt for spacer if needed
- The Middle Mounting Bracket on the driver side, has a single Blade to attach to the body of the vehicle.
- Passenger Side
 - 1. The steps are the same for the passenger side except:



- The Middle Bracket on the passenger side is mounted the same way as the front brackets on both driver and passenger side.
- Drill through the bracket and the step with a ¼" drill bit (be careful of any wiring that may be on the top of the step).
- After drilling the first hole insert a ¼-20 x 2" Button Socket Cap (70119) through the Slotted Aluminum plate hole (See figure 2.a), with a flat washer on both sides, and a ¼-20 Nylock Nut (70008).
 - The head of the bolt should be on the top of the step (i.e. the bolt is going down and the nut is on the bottom of the vehicle).
- Repeat steps "ii" and "iii" until there are two bolts attaching the front mounting bracket to the bottom of the step

2. <u>Limited Remedies</u>. Subject to any limitations and exclusions described herein, and subject to Aluminess' determination of warranty eligibility, Aluminess will remedy defects in product materials and/or workmanship of any product by repairing or replacing such defective product, which shall be within Aluminess' sole discretion, without charge for parts or labor. Aluminess may elect in its sole discretion not to replace a defective product and issue the purchaser a refund equal to the purchase price of any defective product or purchaser may elect to receive a credit (equal to such refund) toward the purchase of new Aluminess products. Repair or replacement of a defective product or providing a refund or credit to purchaser will be purchaser's exclusive remedy under this warranty. Damage to a purchaser's vehicle, cargo and/or any other person or property is expressly excluded from the Aluminess warranty.

3. <u>Modification</u>. Aluminess products are designed to be mounted to factory equipped vehicles. Aftermarket additions to such vehicle may or may not require modification of an Aluminess product. The Aluminess warranty does not extend to any Aluminess products that are modified to fit around other otherwise accommodate or be compatible with any aftermarket vehicle accessories or alterations. Aluminess does not guarantee fitment with any other aftermarket accessories or modified vehicle, and it is up to purchaser to determine fitment prior to purchasing any Aluminess product.

4. <u>Damage</u>. Before using any Aluminess products, the purchaser or user will determine the suitability of the product(s) for their intended use(s) and the purchaser or user shall assume all responsibility and risk in connection therewith.
